As Fortune REIT's first dual recognition in governance and ESG from this program, it reaffirms our leadership in transparent governance, climate action, and stakeholder value creation.

Raising the Bar in Governance and Transparency - Fortune REIT has consistently strengthened its governance framework with enhanced board oversight of sustainability, proactive risk management, and greater ESG disclosure transparency. The board's longstanding diversity and independence remain central to effective decision-making and sustainable value creation. In 2024, Fortune REIT advanced its climate-related financial risk analysis from qualitative to quantitative assessment, providing greater clarity and precision in understanding the risk landscape. Furthermore, the 2024 ESG Report substantially adopted the IFRS S2 Climate-related Disclosures ahead of regulatory timelines, demonstrating a proactive commitment to transparency.

Accelerating Decarbonization and Driving Social Impact - As the first Hong Kong REIT to commit to the Science Based Targets initiative, Fortune REIT has achieved a 41.3% reduction in Scope 1 and 2 emissions by end-2024 (against a 2019 baseline). Additionally, 77% of its borrowings are now sustainability-linked, aligning capital with measurable ESG outcomes. Beyond environmental impact, Fortune REIT continues to invest in community and tenant engagement, fostering vibrant and resilient neighbourhoods.

Ms Justina Chiu, Chief Executive Officer of the Manager, remarked, "These awards affirm our team's dedication to principled governance and responsible business practices. Amid Hong Kong's ongoing economic transformation and the global imperative to address climate change, sound governance and ethical leadership are more important than ever – as they safeguard stability, reinforce trust, and enable long-term resilience. True excellence in governance and ESG is not about meeting standards, but driving endurance, strengthening accountability and contributing meaningfully to the greater good. With these recognitions, we reaffirm our commitment to advancing best practices and investing in solutions that shape a sustainable and compassionate future for all."
